The babies are still being lined up, they are still screaming and crying. Can we hear them? All over the globe they are crying and sometimes dying. Can we hear them? Can we feel them? Are we allowing babies to be risked on the alters of medical tables in clinics all over the world?

ALL the ingredients in vaccines are toxic by nature

Even for the Vitamin K shot, the least offensive injection of all, this is true. Roche's vitamin K product KONAKION contains ingredients such as phenol (carbolic acid -- a poisonous substance distilled from coal tar), propylene glycol (derived from petroleum and used as an antifreeze and in hydraulic brake fluid) and acetic acid (an astringent antimicrobial agent that may drastically reduce the amount of natural vitamin K that would have otherwise been produced in the digestive tract).

As reported in the PDR (Physician's Desk Reference) and as published in the IM vitamin K packet inserts for Merck, Roche and Abbott, ³ Studies of carcinogenicity, mutagenesis or impairment of fertility have not been conducted with Vitamin K1 Injection (Phytonadione Injection, USP).²

Baby Lucas, for example, was born at 41 weeks of gestation on May 16, 2002. He was in excellent health until the day of his vaccination on July 23rd when he was 9 weeks of age. He was simultaneously administered seven vaccines (DTaP, Hepatitis B, Hib, IPV, and Pneumococcal vaccine). Baby Lucas died soon after and his parents have been accused of murdering him. On that fateful afternoon Baby Lucas received the following chemicals injected from these vaccines. (Please note this is an incomplete list. There is no mention, for example, of the mineral oil which is supposed to be the least toxic element in the vaccine liquid.)

DTaP

Each dose (0.5 mL) contains 0.625 mg aluminum; 25 Diphtheria toxoid; 10 tetanus toxoid; 25 m g pertussis toxin; 25 m g filamentous hemagglutinin; 8 m g pertacin; 2.5 mg 2-phenoxyethanol; 4.5 mg sodium chloride; and 0.1 mg formaldehyde.

Hepatitis B
(Comvax)

Each dose (0.5 mL) contains 0.25 mg aluminum; 10 m g of hepatitis B antigen; 4.5 mg sodium chloride; 0.49 mg disodium phosphate dihydrate; and 0.35 mg sodium dihydrogen phosphate dihydrate.

Haemophilus
Influenzae (Hib)

Each dose (0.5 mL of 0.4% sodium chloride solution) contains 10 m g of purified Haemophilus capsular polysaccharide.

Inactivated
Polio Vaccine
(IPV)

Each 0.5 mL dose contains 40 D antigen units of type 1, 8 D antigen units of type 2, and 32 D antigen units of type 3 poliovirus. Also present are 0.5% of 2-phenoxyethanol and 0.02% of formaldehyde (Preservatives), 5 ng neomycin, 200 ng streptomycin, and 25 ng polymyxin.

Pneumococcal
vaccine
(Prennar)

Each dose (0.5 mL of vaccine) contains a mixture of purified polysaccharides of 23 most prevalent or invasive pneumococcal types of Streptococcus Pneumonia dissolved in isotonic saline solution containing 0.25% phenol as preservative.

There are no scientific studies anywhere on earth that can testify to the safety of such a mixture pumped into an infant.

Special Note: Add toxic levels of mercury to the above list for all third world countries.

Other components in vaccines that are not normally toxic inside the vaccine vial are the foreign proteins which are supposed to act as allergens, but there is a clear and present danger injected these proteins directly into the body bypassing the digestive system. In the absence of gastro-intestinal juices in the blood, these proteins can decompose (putrefy) yielding the extremely poisonous byproducts belonging to the group of ptomaines, creatins, xanthins, purines, indoles, skatols, phenols, leucomaines, uric acids, and indoxyl-sulphuric acids. The most acute reaction to this putrefying process may be anaphylactic shock, possibly leading to convulsions and even instantaneous death.

They say that vaccine injuries are rare and that the risk of the diseases is greater than the risk of injury from the vaccines. I've looked into the eyes of hundreds of parents of injured and dead children, and I know first hand that when your child is affected, the risks are 100%.

And what about the rest of the composition, the bulk liquid that makes up the primary content of vaccines? Mineral oils, seemingly totally safe by comparison to mercury, aluminum and formaldehyde, are common components of vaccines and one would not expect them to induce the production of pathogenic auto-antibodies and an inflammatory immune response when injected into children. Mineral oils are used as adjuvants in vaccines – substances that enhance the immunogenicity of an antigen. But even here there is trouble injecting such benign substances directly into biological systems. It has been known for some time that some mineral oils can induce autoimmunity in the form of arthritis, and when tested on mice they do indeed produce animal models for arthritis suggesting of course that these oils could be inducing autoimmunity in susceptible people.

ALL the ingredients in vaccines are toxic by nature. This means that there is no such thing as a safe vaccine. None! We can only thank God when our children survive the experience unharmed.
